Welcome to U10 Team Observations with FC Portland! We hope that this information sheet will help you make your way through the 2010-2011 soccer season. Please refer to www.fcportland.org for information regarding U11-U14 Team Tryouts.

Who may attend the U10 Observations?

If you are a player in good standing who was born between August 1, 2000 and July 31, 2002, you are eligible for selection to one of our U10 Teams and welcome to participate in the U10 observations.

How do I register for the U10 Observations?

Please complete the 2010-2011 U10 Team Observation Form and return it to the FC Portland Academy office or bring the completed form to the first observation day on **Tuesday, May 11**. There is no fee to participate in the U10 Team Observations.

What happens after the U10 Observations?

Players will be contacted by the U10 Coach after the final observation day and either selected to an U10 Team or encouraged to join or continue with the Jr Academy program for the 2010-2011 season. Players selected to a U10 Team will confirm their acceptance and arrange to pay the **non-refundable Membership Fee** and the **non-refundable Training Fee** according to the Payment Schedule below. Upon selection to an U10 Team, players may choose to participate in both the Summer/Fall and Winter/Spring Seasons.

MEMBERSHIP and TRAINING FEES

FC Portland provides a 10-month training program for U10 teams, which is divided into 2 seasons: Summer/Fall and Winter/Spring. Non-refundable Fees (Player Membership Fee plus Team Training Fee) cover the following costs:

- Coaches' compensation for June-November 2010 and/or January-April 2011.
- All registration fees for: players, coaches, and managers; Fall and/or Spring League team competition.
- Use of two uniform jerseys.
- Use of game balls and other training equipment.
- Use and maintenance of fields at Liberty HS and Hillsboro HS.
- Administrative services from a professional staff.

The following costs are among those not covered by Membership or Team Training Fees. Expenses for travel, tournaments, and other optional competition are shared by participating players.

- Required uniform and training gear, to be purchased at The Far Post.
- Fees for optional training or competitive programs.
- Team, coach and manager travel expenses to league games past Salem.
- Team, coach and manager travel expenses to tournaments requiring entry fees and/or travel.

I give my permission for all medical care deemed necessary by a duly licensed doctor of medicine in my absence, for my dependent.

Payment of Fees & Other Costs: I, the parent/guardian of the registrant, agree to pay FC Portland Academy the full Membership and Training Fees plus any invoicing fees as indicated above. I understand that payments are non-refundable, and I will be responsible for paying any unpaid fee balance at the time of withdrawal should s/he withdraw from the program at any time for any reason other than serious injury. Furthermore, I understand that Fees will cover the following membership, training, and league competition costs from during the enrollment season: league registration fees; coaches' compensation; use of field equipment; and playing fields at Liberty HS or Hillsboro HS. I understand that Fees do not cover any additional expenses, including (but not limited to): coaches' league and tournament travel; player tournament travel and participation; indoor league fees; required uniform or training gear; or lost or damaged uniform jerseys.
